## Key topics:

- Irrigation leak was fixed and insulating cover placed over anti-siphon pipes.
- Minutes of the 1/16/07 Board meeting were reviewed and approved for mailing to all Homeowners along with a copy of the meeting's agenda.
- A suggestion for a possible HOA Newsletter was made.
- The following was approved by the Board for fines covering selected CC&R violations:
