As explained in the CC&R's, exterior improvements or modifications to your property require approval by our Design & Landscape Review Committee. We want to help you make this an easy process to fill out the proper paperwork and get it approved in a timely manner.

The following pages are the form we use for applying for such approval. The information on the form should include the following items with your request:

The Architectural Request Submittal form completed and signed along with some scale drawings and pictures.

A picture of where the project is to be placed on your lot

A Plat Plan – A site plan indicating the dimensions relating to the existing dwelling and property lines setbacks, etc., and the improvement to be installed. This is a bird's eye view of your lot.

Front, Back, Top and Side Views – If appropriate, showing finished appearance of the improvements in relation to the existing dwelling and property lines. Viewed from all sides and viewed from the top.

Specifications – Description detailing materials to be used, including color samples attached; drawing or brochure of structure indicating dimensions and color.

To avoid delay of committee action, please include all information the committee will need to make a decision. Attach additional pages if needed.

Your request will either, be approved, denied or returned for noted additional information needed after review.
